Notice for inviting the applications for Apprenticeship

1. National Highways & Infrastructure Development Corporation Limited (NHIDCL) , a Corporation under the Ministry of Road Transport & Highways is executing construction/ up-gradation/ widening of National Highways in the North-Eastern Region and areas that share International boundaries with neighboring countries.

2. NHIDCL intend to implement an Apprentices scheme to develop employable skills among the youth of the country through practical training. Applications are invited from eligible Indian National candidates for thirty Apprentice seats under the following categories :

3. Requirements for Apprenticeship Applicant:

- The applicant should fulfill all requirements of the Apprentices Act, 1961.
- Apprentice applicant should have an Aadhaar number.
- The applicant should possess the prescribed educational qualification as mentioned above.
- The applicant should not be below 18 years of age as on the crucial date as prescribed herewith.

4. Last date for submission of application: 31.01. 2023.

5. The candidates who are aspiring may enroll in the NATS portal www.mhrdnats.gov.in. After the enrollment is approved , apply to Establishment -NHIDCL(Note: The process manual for applying establishment is available in the 'help' section of the dashboard of the candidate, document available at https://portal.mhrdnats.gov.in/boat/manuals/NATS-Student-Apply-for-Apprenticeship_User-manual.pdf). **No application by any other mode (by hand or by post or by e-mail) shall be accepted under any circumstances.**

6. The aspiring candidates to note the following :

- A stipend of Rs. 15,000/- per month will be paid during apprenticeship training, in case the Apprentice is engaged for the training in the State of his/her domicile.

(b) A stipend of Rs. 20,000/- per month will be paid during apprenticeship training, in case the Apprentice is engaged for the training in the State other than the State of his/her domicile.

(c) The provisions of PF, ESIC etc. shall not be applicable to any Apprentice

(d) Crucial date for deciding eligibility (viz. age etc.) of the Candidates shall be 20.02.2023.

(e) Any change or amendment in Apprenticeship notification will be posted on the NHIDCL website only.

(f) Incomplete applications or those received after the prescribed date shall be summarily rejected.


(g) The applicant should be in possession of all the requisite certificates in the support of their claim by the closing date of the application.
