- Post of Manager MPIDC opens to MP Domicile & Non-Domicile both.
- Number of post under unreserved and vertical, horizontal reservation may change under any legitimate circumstances.
- All the categories of Non Domicile Candidates shall be treated as UR Category Candidates.
- Age Relaxation shall be given to the candidates as per their category of reservation, belonging to MP (MP Domicile) only.
- Horizontal Reservation in number of post are allotted for Women candidate (Mp Domicile) only.
- Horizontal Reservation for Divyang candidates (MP Domicile only) shall be assigned to the category he belongs, example SC, ST, OBC, UR, EWS.

- vii) The MPIDC reserves the right to fill or not to fill any of the vacancies. Mere appearance in the selection list does not give any right to the candidate for appointment.
- viii) Age relaxation upto 05 years other than the normal upper age 30 years shall be available to candidates already serving with state of MP or it's Corporation/Board or similar entities as a regular employee.
- ix) Final selection result of this advertisement shall be subject to final outcome on various petitions pending before the Hon'ble Madhya Pradesh, High Court in the context of reservation to OBC. During the pendency of such petition selection result may be declared in accordance with GAD guidelines dated 29.09.2022 or any other such instruction in the subject matter.
- x) Any necessary change in the context of this advertisement to comply with relevant instructions/ guidelines of the Government of MP or Board of the corporation shall be immediately notified in the portal of MPIDC and MPONLINE. - i) Candidates belonging to SC/ ST/ OBC (Non Creamy Layer) categories and women candidates having M.P. domicile and Handicapped candidates having M.P. domicile shall get relaxation in upper age limit to an extent of five (5) years only.

- ii) OBC (Creamy Layer) category Candidates shall be considered in UR Category.
- iii) Age Relaxation shall be given to the candidates as per their category of reservation only, belonging to MP (MP Domicile).
- iv) Age relaxation shall also be available to serving regular employee of state or it's corporation/board or similar entities.

However, maximum age limit including all age relaxation shall be upto 35 years only.

#### 5. Reservation:-

- i) The provisions of vertical and horizontal reservation shall be applicable as per prevailing rules of Government of Madhya Pradesh.
- ii) The reservation of position shall be applicable only for the candidates having MP Domicile.
- iii) Caste certificate to be submitted in relevant cases issued by competent authority of State of Madhya Pradesh only shall be treated as valid.
- iv) The candidates of OBC category (Non-creamy layer) shall have to submit declaration that they do not come under "Creamy layer" as per the as on date bench mark standards set and notified by the Government of Madhya Pradesh. Following format should be used for "Declaration." (**Annexure-"One"**)
- v) Candidates belonging to EWS category shall have to submit the certificate to that effect issued by the competent authority of State of Madhya Pradesh in format prescribed by the Govt. Of M.P.

#### 6. How to apply:-

The candidates may apply through MP online portal only ([www.mponline.gov.in](http://www.mponline.gov.in)) or using the link provided on MPIDC Bhopal website "[www.invest.mp.gov.in](http://www.invest.mp.gov.in)". The scanned copy of following documents shall be uploaded by the applicant:-

- iv) Caste certificate, in case of candidates belonging reserved category, issued by competent officer (Sub Divisional Officer) of Government of MP Only in prescribed format/ Digital Certificate.
- v) Domicile Certificate in case of candidate seeking reservation & age relaxation.
- vi) In case of EWS candidate, a valid certificate issued by competent officer of Government of M.P. for being in category of "Economic Weaker Section."
- vii) Declaration of being a "Non Creamy Layer" OBC candidate.
- viii) Declaration that the candidate is regular employee of Government of M.P. or it's Corporation/Board or similar entities. If seeking age relaxation.
- ix) In case of "Divyang (PH)" candidate valid certificate of "Permanent Disability" issued by "District Medical Board" constituted under notification no F-8-1-Seventeen-Med-2 dated 09.01.2009 or subsequent amendments if any. However such certificate issued on or after 01.06.2021 shall be treated valid only if issued through UDID portal <http://www.swavlambancard.gov.in>.

## 7. Application fee and other charges:-

- i) The recruitment shall be done through On-line exam meant for applicant's who will submit their online application.
- ii) Portal fee including taxes Rs 510+GST per candidate shall be payable to MPONLINE through electronic mode.
- iii) Payment of application fee for MPONLINE can also be made in cash in MP Online KIOSK.
- iv) No Extra charges shall be payable for scanning of photographs etc. to the KIOSK apart from the portal charges.
- v) After payment, one time edit facility shall be available to the candidates for which portal charges of Rs 50+GST shall be payable to MP ONLINE through electronic mode.
- vi) Objection calling fee of Rs 50+GST shall be payable to MP ONLINE through electronic mode.

## 8. Selection Procedure:-

- i) The online academic assessment test shall be conducted by MP Online at various test centres of Bhopal, Gwalior, Jabalpur, Indore, Ujjain and Satna only.

- ii) The number of cities for online academic assessment test can be increased or decreased depending upon number of candidates or due to any other urgent issue with best possible allocation of centre nearest to their postal address within State.
- iii) Merit List for the purpose of interview shall be prepared by MP Online on the basis of online test score.
- iv) In case Candidates having same score in examination, then shall prefer Date of Birth (DOB) of candidates; elder candidates shall get upper rank.
- v) In case Score and DOB of candidates comes to be same then shall prefer to 10<sup>th</sup> passing year, earliest candidates shall get upper rank.
- vi) The recruitment shall be based on online examination to be conducted by MPONLINE. and there shall be 100 objective type questions (4 marks each) with total 400 Marks, 1 (one) negative marking for each wrong answers shall be assigned.
- vii) Time duration of online examination shall be 2 hours (120 minutes).
- viii) Before preparation of merit list for interview purpose, a category wise minimum cutoff marks may be fixed by MPIDC in the larger interest of MPIDC to ensure quality & efficiency of human resource to be recruited.
- ix) Final selection list shall be subject to final verdict of Hon'ble Madhya Pradesh High Court, Jabalpur in the various petitions in the matter of OBC reservation. Till the pendency of such petition main and provisional part of selection result shall be as per guideline of letter no F-07-46/2021/GAD/one dated 29.09.2022 issued by Government of Madhya Pradesh, Department of General Administration Department.
- x) This selection process shall be governed by the "Corporation's Service Rule 2017."
- xi) OBC candidate "non creamy layer" shall be required to submit the declaration in the format prescribed by the state that they fulfil all the criterion decided by the Government in latest notification.
- xii) Certificate of permanent disability issued by the competent authority of the state District Medical Board in accordance with prevailing rules of the state of Madhya Pradesh, Department of Public Health & Family Welfare, only shall be acceptable.

## 11. General conditions :-

- i) The Candidates should be an Indian National.
- ii) Candidates working in the Government/Semi-Government/Public Sector, satisfying the eligibility criteria of education and age shall have to produce N.O.C. from their present employer at the time of interview and MPIDC reserves the right to verify document submitted by the applicant. If any of the information given by the applicant is found incorrect, his/her candidature shall be cancelled at any stage of selection /appointment process and thereafter.
- iii) Upper age relaxation for all eligible categories as per prevailing rules of Government of M.P. shall be up to 5 years. However maximum age limit in all such cases shall be 35 years.
- iv) The reserve category candidates selected in merit, availing relax standard shall be considered against vacancy of the respective category.
- v) The appointment letter to the candidates shall be issued on the basis of final merit list subject to verification of original documents.
- vi) Disqualification for appointment to the post shall be in accordance with the prevailing provisions of Government of M.P.
- vii) On selection, initial intimation letter may be sent to the candidates through email on their registered email id in application.
- viii) As per the final selection list based on merit, candidates shall be given appointment order as a probationer and they shall be given at least 30 days time to join at the place of posting, failing which their appointment shall stand cancelled and waiting list shall be operated.
