- 4. The responsibility to establish eligibility for the post applied for with reference to all the prescribed eligibility conditions rests with the applicant.
- 5. <u>Remuneration</u>: Monthly remuneration is negotiable based on educational qualification and experience in the relevant field. The candidate should produce, last three pay slips for deciding the remuneration.

#### 6. Other Instructions:
